2014 SALARY ORDINANCE

WHEREAS THE TOWN COUNCIL OF THE TOWN OF WHITELAND HAS SET FORTH THE MAXIMUM SALARIES AND WAGES FROM AND AFTER THE FIRST DAY OF JANUARY 2014 FOR ELECTED OFFICIALS, APPOINTED OFFICIALS APPOINTED EMPLOYEES AND ALL OTHER EMPLOYEES OF THE TOWN OF WHITELAND, INDIANA AS FOLLOWS:

SECTION 1 - PLANNING COMMISSION (7 MEMBERS) AT \$15.00 PER MEETING PER MONTH MAXIMUM, PAID ONLY IF IN ATTENDANCE AT THE REGULAR SCHEDULED MEETING.

SECTION 2 - BOARD OF ZONING APPEALS (5 MEMBERS) AT \$15.00 PER MEETING PER MONTH MAXIMUM, PAID ONLY IF IN ATTENDANCE AT THE REGULAR MEETING.

SECTION 3 - THE ECONOMIC DEVELOPMENT COMMISSION (3 MEMBERS) AND RDC (5 MEMBERS) AT \$15.00 PER MEETING PER MONTH MAXIMUM PAID ONLY IF IN ATTENDANCE TO BE KEPT BY THE CLERK-TREASURER

SECTION 4 - THE PARK BOARD (4 MEMBERS) AND THE STORM WATER MANAGEMENT BOARD (3 MEMBERS) AT \$15.00 PER MEETING PER AT THE REGULAR SCHEDULED MEETING.

SECTION 5 - THE PLANNING COMMISSION, BOARD OF ZONING APPEALS, ECONOMIC DEVELOPMENT COMMISSION, RDC, PARK BOARD, & STORM WATER MANAGEMENT BOARD, TO BE PAID EACH JUNE 15TH AND DECEMBER 15. THE ATTENDANCE TO BE KEPT BY THE CLERK-TREASURER.

SECTION 6 - SALARY OF ALL FULL TIME EMPLOYEES SHALL INCLUDE HOLIDAY PAY, UNDER THE EMPLOYEE HANDBOOK, ADOPTED BY THE WHITELAND TOWN COUNCIL, JUNE 11, 2007.

SECTION 7 - ANNUAL SALARIES FOR DEPUTY MARSHALS IS BASED ON A 28 DAY TOUR OF DUTY AT 171 HOURS. HOURS WORKED IN EXCESS OF 171 HOURS PER 28 DAY TOUR OF DUTY SHALL BE COMPENSATED AT ONE AND ONE HALF TIMES THE NUMBER OF HOURS IN EXCESS OF 171, BY THE HOURLY RATE, AS DEFINED UNDER THE FLSA

SECTION 8 - CLERK-TREASURER SHALL PROCESS ALL PAYROLL BI-WEEKLY WITHOUT TOWN COUNCIL APPROVAL.

SECTION 9 - ALL APPOINTED FULL TIME EMPLOYEES AND ALL OTHER FULL TIME EMPLOYEES SHALL BE REQUIRED TO WORK 40 HOURS PER WORK. SALARIES AND WAGES ARE BASED ON 2088 HOURS IN THE YEAR 2013, EXCEPT FOR DEPUTY MARSHALS, WHERE SECTION 7 ABOVE SHALL PREVAIL. ALL EMPLOYEES NOT EXEMPT UNDER THE FAIR LABOR STANDARDS ACT (FLSA) ARE DENOTED WITH AN ASTERISK (\*) BY THE POSITION.
