6. The structure cannot be occupied until all inspections have been made and approved, and a Certificate of Occupancy has been issued by the Building Commissioner.
7. The undersigned owner and/or agent understands that the approval of this application does not constitute a privilege to violate any applicable government ordinances, codes, or laws. In addition, any omission or misrepresentation of fact, with or without intention of the undersigned, or any alteration or change from revocation of any permit issued which was based on the approval of this application.
8. The Town of Whiteland does not have the authority to enforce subdivision covenants, or local Homeowners Association covenants.
