

**ORDINANCE 2014-11**  
**AN ORDINANCE AMENDING TITLE VII, THE TRAFFIC CODE**

WHEREAS, Title VII of the Code of Ordinances (the "Traffic Code") for the Town of Whiteland, Indiana, (the "Town") provides regulations for operation of vehicles within the Town; and

WHEREAS, the Town from time to time must revise its traffic ordinances and schedules to accommodate traffic improvements and change in traffic flow within its corporate boundaries; and

WHEREAS, the Town now desires to amend Chapter 71 of the Traffic Code to include revised and additional schedules for through streets, stop intersections, signalized intersections, roundabout intersections, no parking areas, truck streets, and speed limits within the Town; and

WHEREAS, in the interest of clarity and conciseness, the Town desires to make corresponding changes to Chapter 70, General Traffic Regulations, and Chapter 72, Town Parking.

NOW THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF WHITELAND, INDIANA, AS FOLLOWS:

Section 1. Chapter 70, General Traffic Regulations, shall be amended to read as follows:

**§ 70.02 SPEED LIMITS.**

(A) No person shall drive a vehicle upon streets and highways under the jurisdiction of the town at a speed greater than is reasonable and prudent under the conditions and having regard to the actual and potential hazards then existing. In every event, speed shall be so restricted as may be necessary to avoid colliding with any person or vehicle or other conveyance on or entering such street or highway in compliance with legal requirements and with the duty of all persons to use due care.

(B) No person shall drive a vehicle on a Town street or highway at a speed in excess of 30 miles per hour, unless specifically otherwise posted, in which case the posted speed shall be the maximum lawful speed. The maximum lawful speed of a vehicle on a street which does not have a posted speed shall be 30 mph.

**§ 70.03 TRUCK TRAFFIC.**

(A) It shall be unlawful for any person to drive a motor vehicle with a gross weight more than 11,000 pounds or more than 30 feet long on any street, alley or right-of-way in the town, except for those streets designated as truck streets; provided that such vehicles may drive on any street, alley or right-of-way within the town for the purpose of local deliveries or the rendering of services to the residences of the town.

(B) It shall be unlawful for any person to drive a motor vehicle with a gross weight more than 11,000 pounds or more than 30 feet long on any town owned parking lot, driveway, or approach surrounding or adjacent to the Whiteland Town Hall, 549 Main Street, Whiteland, Indiana 46184.

(C) When any street is posted with signs indicating the maximum gross weight permitted thereon, no person shall operate any vehicle on such street with a gross weight in excess of the amount specified on such signs.

**§ 70.99 PENALTY.**

(A) Any person violating the provisions of § 70.02 and 70.03 shall, upon conviction, be fined in a sum not exceeding \$100, plus court costs.

(B) Any person violating the provisions of § 70.03 shall be subject to the penalty imposed for a Class C infraction, as set forth in I.C. 34-28-5-4(c). Accordingly, this section shall be enforced by the provisions of I.C. 34-28-5.

Section 2. Chapter 71, Traffic Schedules shall be amended to read as follows:

The Town Street Department, in conjunction with the Town Marshall, are hereby instructed and authorized to erect the necessary traffic control signs and devices to carry out the provisions of the schedules herein provided.

**SCHEDULE I. THROUGH STREETS.**

The following streets and intersections are hereby declared through streets and stop intersections. Unless otherwise directed by a police officer or when stop signs are placed at the entrance to through streets or stop

intersections, the driver of a vehicle approaching such signs shall stop as required by law at any marked line on the roadway, or if none, before entering any crosswalk or the intersection.

Section 3. Section 2 of Chapter 72, Town Parking, shall be amended to read as follows:

**§ 72.02 PARKING ON TOWN STREETS AND RIGHTS-OF-WAY.**

No vehicle shall be permitted to park on town streets or rights-of-way between the hours of 2:00 a.m. and 5:00 a.m. on those streets in subdivisions that have curbs. In subdivisions that do not have curbed streets, vehicles shall not park on the paved portion of the street during the time, stated above. No parking or stopping shall be permitted on the parts of town streets where parking is designated on the traffic schedule for parking as prohibited at all times, or where authorized signs are posted indicating that parking is prohibited.

Section 4. The Ordinance shall be in full force and effect on January 1, 2015.
