SECTION 1- ECONOMIC DEVELOPMENT COMMISSION (3 MEMBERS), REDEVELOPMENT COMMISSION (5 MEMBERS), PLAN COMMISSION (7 MEMBERS), BOARD OF ZONING APPEALS (5 MEMBERS), PARK BOARD (4 MEMBERS) AND STORM WATER MANAGEMENT BOARD (3 MEMBERS) AT \$15.00 PER MEETING PER MONTH MAXIMUM, PAID ONLY IF IN ATTENDANCE AT THE REGULAR SCHEDULED MEETING.

SECTION 2 -- THE ECONOMIC DEVELOPMENT COMMISSION, REDEVELOPMENT COMMISSION, PLAN COMMISSION, BOARD OF ZONING APPEALS, PARK BOARD AND STORM WATER MANAGEMENT BOARD, TO BE PAID ON THE REGULAR SCHEDULED PAY DATE CLOSEST TO EACH JUNE 15<sup>TH</sup> AND DECEMBER 15<sup>TH</sup>. THE ATTENDANCE IS TO BE KEPT BY THE CLERK-TREASURER.

SECTION 3 – SALARY OF ALL FULL TIME EMPLOYEES SHALL INCLUDE HOLIDAY PAY, UNDER THE EMPLOYEE HANDBOOK, ADOPTED BY THE WHITELAND TOWN COUNCIL, JUNE 11, 2007.

2015 SALARY ORDINANCE

SECTION 4 – ANNUAL SALARIES FOR DEPUTY MARSHALS IS BASED ON A 28 DAY TOUR OF DUTY AT 171 HOURS. HOURS WORKED IN EXCESS OF 171 HOURS PER 28 DAY TOUR OF DUTY SHALL BE COMPENSATED AT ONE AND ONE HALF TIMES THE NUMBER OF HOURS IN EXCESS OF 171, BY THE HOURLY RATE, AS DEFINED UNDER THE FLSA.

SECTION 5 – CLERK-TREASURER SHALL PROCESS ALL PAYROLL BI-WEEKLY WITHOUT TOWN COUNCIL APPROVAL.

SECTION 6 – ALL APPOINTED FULL TIME EMPLOYEES AND ALL OTHER FULL TIME EMPLOYEES SHALL BE REQUIRED TO WORK 40 HOURS PER WEEK. SALARIES AND WAGES ARE BASED ON 2088 HOURS IN THE YEAR 2015, EXCEPT FOR DEPUTY MARSHALS, WHERE SECTION 4 ABOVE SHALL PREVAIL. ALL EMPLOYEES NOT EXEMPT UNDER THE FAIR LABOR STANDARDS ACT (FLSA) ARE DENOTED WITH AN ASTERISK (\*) BY THE POSITION.
