TOWN OF WHITELAND, INDIANA
ORDINANCE 2017-04: AN ORDINANCE AMENDING ORDINANCE 2016-07 “2017 SALARY ORDINANCE”
Pursuant to IC §36-5-3-2(b)

WHEREAS: IC §36-5-3-2(b) confers upon the Whiteland Town Council (“Council”) the power to provide reasonable compensation for the Town of Whiteland (“Town”) employees; and

WHEREAS: The Town Council adopted Ordinance 2016-07 on November 14, 2016 providing for compensation to be paid to officials and employees of the Town for calendar year 2017; and

WHEREAS: It has been determined that offices of the Town Administration should be reorganized in order to provide funding for additional part time positions comprised of 1) Administrative Assistant—Town Manager (Part Time) and 2) Finance Office (Part Time)

WHEREAS: The salary ordinance must be amended to reflect the updated positions and salary.

NOW THEREFORE, be it ordained by the Town Council of the Town of Whiteland, Indiana that the following table is hereby amended as part of Ordinance 2016-07.

Section 1: Amendment: The 2017 Salary Ordinance, Ordinance 2016-07, is hereby amended by adding funding as follows:

Section 5: Duration & Effective Date: The provisions of this Ordinance shall become and remain in full force and effect o the date of passage and adoption.
