ORDINANCE 2017 - 07

AN ORDINANCE REDUCING CERTAIN APPROPRIATIONS IN THE 2017 TOWN BUDGET

WHEREAS: it has been shown and determined that certain existing appropriations within the 2017 Town Budget now have unobligated balances that will not be needed for the purposes for which appropriated.

NOW, THEREFORE BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF WHITELAND, INDIANA AS FOLLOWS:

**Section 1.** It has been shown that certain existing appropriations now have unobligated balances that will not be needed for the purposes for which appropriated, it is further ordained that the following existing appropriations shall be reduced in the following amounts:

FUND NAME: Local Road & Street:

FUND NAME: Rainy Day:

Materials	\$1,000.00

FUND NAME: Cumulative Capital Improvement (CCI):

Capital Outlays	\$10,000.00

FUND NAME: Cumulative Capital Development (CCD):

<u>Major Budget Classification:</u>	<u>Amount of Reduction</u>
Capital Outlays	\$100,000.00

**Section 2.** This Ordinance shall be in full force and effect from and after its adoption by the Town Council. The provisions of this Ordinance shall supersede the provisions of any previous Ordinance in conflict herewith.

INTRODUCED to the Town Council on the 14<sup>th</sup> day of November, 2017.


PASSED through first reading by the Town Council on the 14<sup>th</sup> day of November, 2017, by a vote of 5 in favor and 0 against.


