

WHITELAND TOWN COUNCIL
ORDINANCE NO. 2018-02
AN ORDINANCE ESTABLISHING A NEW WATER RATE FOR WATER SALES
FROM A BULK WATER SERVICE STATION

WHEREAS, the Town Council of the Town of Whiteland, Indiana (the "Town Council") has established rates and charges for the waterworks system of the Town of Whiteland, Indiana (the "Town");

WHEREAS, pursuant to Ind. Code § 8-1.5-3-8, the Town Council shall furnish reasonably adequate services and facilities to the citizens of the Town;

WHEREAS, pursuant to Ind. Code § 8-1.5-3-8.1, this Council may change or adjust its existing schedule of fees by ordinance after providing notice and conducting a public hearing;

WHEREAS, Ind. Code § 8-1.5-3-8 authorizes the Town Council to adopt by ordinance a nondiscriminatory, reasonable and just schedule of rates and charges for water services rendered by the Town's waterworks system;

WHEREAS, in accordance with Ind. Code § 8-1.5-3-8.1, notice has been given of the public hearing on the proposed rates contained herein;

WHEREAS, a public hearing was held before the Town Council, at which time testimony from interested persons was received, after introduction of this ordinance; and

WHEREAS, the Town Council has determined that it would be in the best interest of the citizens of the Town to offer the sale of water from a Bulk Water Service Station for wholesale, commercial, and other bulk water use.

NOW, THEREFORE, BE IT ORDAINED by the Town Council of the Town of Whiteland, Indiana that:

SECTION 1. It is in the best interests of the citizens of the Town to establish a Bulk Water Service Station for the voluntary purchase of water through the Town's waterworks system for wholesale, commercial, and other bulk water use at a nondiscriminatory, reasonable, and just rate and charge.

SECTION 2. The Whiteland Code of Ordinances (a.k.a. Whiteland Municipal Code), Section 51.35, shall be amended to add a new section (C), to read as follows:

§ 51.35 RATES AND CHARGES.

* * * * *

(C) *Bulk Water Service Stations.* Water purchased through a Bulk Water Service Station shall be charged at the rate of \$0.55 per 100 gallons.

SECTION 3. The Council hereby authorizes and directs the appropriate officials and representatives of the Town to take all necessary actions to implement this Ordinance following final adoption.

SECTION 4. All prior ordinance provisions in conflict herewith are repealed as of the effective date of this Ordinance.

SECTION 5. This Ordinance shall be in full force and effect upon its final adoption.


PASSED through first reading by the Town Council on the 14th day of August, 2018, by a vote of 4 in favor and 0 against.
