

**WHITELAND TOWN COUNCIL
RESOLUTION NO. 2018-01**

**A Resolution Approving The Initial Plan Of Reorganization For The Proposed
Consolidation Of The Town Of Whiteland With The Whiteland Fire Protection District
Pursuant To I.C. 36-1.5-4-18**

WHEREAS, pursuant to the Government Modernization Act found at Ind. Code 36-1.5 *et. seq.*, the legislative bodies of the Town of Whiteland (the “Town”) and the Whiteland Fire Protection District (the “District”) have each adopted initial reorganization resolutions determining that it would be beneficial to the citizens of the Town and the District to consolidate the District into the Town to more effectively and efficiently provide fire protection services to the Town and the District; and

WHEREAS, pursuant to I.C. 36-1.5-4-18, the legislative bodies of the Town and the District have collaborated and prepared an Initial Plan of Reorganization (the “Initial Plan of Reorganization”), which is attached hereto and incorporated herein.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF WHITELAND, INDIANA, THAT:

1. The Initial Plan of Reorganization is hereby approved as the Initial Plan of Reorganization prepared by the legislative bodies of the Town and the District required to be prepared under I.C. 36-1.5-4-18, and is approved for further consideration in accordance with the review and final adoption requirements of the Government Modernization Act found at Ind. Code 36-1.5 *et. seq.*

2. Pursuant to I.C. 36-1.5-4-18(c), the Whiteland Clerk-Treasurer is hereby authorized and directed to post a copy of the Initial Plan of Reorganization on the Town’s Internet web site not more than thirty (30) days after the Initial Plan of Reorganization is approved by both the legislative bodies of the Town and the District. If the plan of reorganization is amended, the Whiteland Clerk-Treasurer is hereby authorized and directed to post the amended plan of reorganization on the Town’s Internet web site within seven (7) days after the amended plan is adopted.

3. This Resolution shall be effective from and after its passage.






