## PEARL STREET PROJECT UPDATE:

NORM GABEHART SPOKE WITH THE INSURANCE COMPANY TO CONFIRM THE RAILROAD IS SATISFIED WITH WHAT WE CAN PROVIDE AND THE PROJECT HAS BEEN PUSHED BACK TO THE END OF SEPTEMBER TO COMPLETE THE JOB.

#### MS4 COORDINATOR STATUS:

NORM SPOKE ON IDEM AND AQUATERRA. WE HAVEN'T RECEIVED ANY COORESPONDANCE FROM REGGIE AT IDEAM LATELY OR AGUATERRA REGARDING OUR AUDIT OR THE STATUS OF APPROVED PERMIT AND PREVISIONS.

## PROJECTS:

THE FIVE PROJECTS APPROVED AT A MAXIMUM OF \$3000.00 PER PROJECT BY THE STORM WATER BOARD WILL BE STARTING THURSDAY SEPTEMBER 10<sup>TH</sup> AND FRIDAY SEPTEMBER 11<sup>TH</sup> THE INTERSTATE LOCATION PROJECT AND THE ONE ON THE CORNER OF MAPLE AND WHITELAND ROAD. BORING OF SEWER LINE ON

540 WHITELAND ROAD DRAINAGE WILL BE BORED WEST OF THE HOUSE INSTEAD OF GOING TO THE EAST SIDE TO INSURE THE ISSUES IN AREA BETWEEN HILL STREET AND MAPLE STREET ARE RESOVLED. THURMAN PROJECT WILL BE DONE AT A LATER DATE DUE TO THE TIME FRAME NEEDED TO DIG UP THE LINE.

THE STATUS ON THE PARKWAY PROJECT IS COMPLETE. THE ELEVATIONS HAVE BEEN MET AND PIPE IS IN GROUND AND IS SEEDED AND STRAWED PLACED.

FRONT STREET HAS SINK HOLES ALONG ROAD. PIPE HAS FAILED. WILL DIG PIPE OUT AND COMPLETELY REMOVE THE PIPE. THE WATER WILL BE REDIVERTED TO THE NORTH TO THE PIPE THE SCHOOL INSTALLED COMING FROM THE DETENTION AREA. THE TOWN IS CORRISPONDING WITH PROPERTY OWNER ON DECISIONS THE TOWN IS MAKING ON THIS PROJECT.

NORM GABEHART SPOKE ON THE GRAPPLING TRUCK AND LEAF MACHINE LOAN. NORM IS CONSIDERING A PROPOSAL TO PAY FOR ONE OF THE MACHINES FROM ACCUMULATED FUNDS WITH A BALANCE OF \$210,000.00 AS LONG AS IT WILL NOT COMPROMISE FUND BALANCES. NORM ASKED FOR AUTHORIZATION TO POSSIBLY FINANCE UP TO 3.1% INTEREST ON EQUIPMENT IF NECESSARY.

DARRELL CLINE MOVED TO CHANGE THE TOP END PERCENGTAGE RATE FOR THE LOAN OF THE EQUIPMENT TO 3.1%. JULIE DWIRE SECONDED THE MOTION AND PASSED 2-0.
