NATHAN BILGER – PLAN AND ZONING DIRECTOR

- -SCOT FORD RESIGNED FROM THE REDEVELOPMENT COMMISSION BEGINNING AUGUST 19, 2013.
- -SIGN CODE WORKSHOPS ARE IN PROGRESS. SIGN ORDINANCE IS DUE TO COMPLETE IN DECEMBER.
