

WHITELAND STORM WATER MGT. BOARD
AUGUST 12, 2015

Julie Dwire called the meeting to order at 7:04pm.

Present: Julie Dwire and Darrell Cline

Others present: Michelle R. Richards – Clerk Treasurer, Norm Gabehart – Town Manager/MS4/ Street Supt., and Stephen Watson – Town Attorney

Darrell Cline made the motion to approve the minutes from July 15, 2015. Julie Dwire seconded the motion and passed 2-0.

Darrell Cline made the motion to approve voucher packet 15-8. Julie Dwire seconded the motion and passed 2-0.

Michelle reviewed financial reports

Norm said the Pearl Street Project is still set to begin at the end of August. Emergency Locates were called in to pump.

Brewer/Front Streets, Poplar Street and Maple did not flood in the last heavy rain. Hill Street was the only back up. Parkway is at the top of the list but too wet to start.

We will set pipe from Professional Carpet westward to help with flooding in that area.

The Woods property is an ongoing issue so we want to run a pipe and a catch basin to catch what runs off the street to help out with their problem. It will be a minimal cost and a big help to them.

Norm met with SSI to talk about pushing a storm sewer pipe on Maple Street. Need sewer lines because three houses do not have sewers so we got the easements. Better option using north side just east of Maple it would help restore a drainage problem also. One homeowner was very cooperative to help. He is getting a quote for Thurman also. He wants the ability to spend up to \$3,000 on sanitary.

Proposed projects 1. West Maple 2. East Whiteland Rd. 3. Woods property 4. Thurman Drive. Norm is requesting authorization from Storm board to adjust the budget so monies in line items can be moved around to meet the needs of each project not to exceed \$3,000 per project and stay within the budget. Darrell Cline made motion to move monies in other line items. Julie Dwire seconded it. Passed 2-0

Received a letter from IOSHA to show we were fined \$7500. IOSHA violations were reduced to \$0. Director will be involved in training with the town.

We would have a 15 day period to appeal to be removed and show we fixed the problem and present pictures for proof.

OTHER BUSINESS:

We are trying to work with New Whiteland to bid together on trash removal.

Norm is working on someone about being on the Storm Board. Water department is hiring another laborer. Administrative Asst. was added for Town Manager.

2016 Budget presented to board. \$300 raises. MS4 diversified to make 3 positions MS4/Building Comm./Utility Coordinator. Storm Board wants to be in on hiring for MS4 position
