  - O D. Hawkins made a motion to approve ORD 2021-11. L. Fleury seconded the motion.

#### Passed 5-0

- Update and Discussion on the Springhill Road Project.
  - Zach Brummett, representative of Wallace Construction.
    - As long as there is good weather the project should stay on course.
    - There is a small problem getting concrete due to the concrete companies lack of employees and cannot deliver.
    - Karnes curbs are almost finished. Streets will follow in approximately 2 weeks after.
    - The target deadline is 15 days behind due to a change order. Looking at mid to late December.
  - o D. Hawkins and R. Hill have been at the construction site daily between the two of them.
- Discussion and Consideration of Town's Specifications for New Roadwork
  - K. McGinnis stated he reached out to INDOT, City of Greenwood's engineer, Johnson County Highway Department for types of asphalt to use.
    - 76-22 is the highest strength available and most expensive.
    - 70-22 is used for 300 semis a day surface for heavy traffic.
    - 64-22 is normally used.
  - o Most road issues are due to sub-base failure.
  - R. Hill suggested for core samples prior to bids for projects.
  - Council would like K. McGinnis to look more into the subgrade.
- RDC Vacancy
  - o John Venter
    - Has three children
    - Whiteland resident
    - Been on the School Board for six years
    - Spent almost a year with Aspire of Johnson County
    - There is a quality of life and financial growth. You shouldn't have to sacrifice one for the other.
  - B. Goedeker made a motion to appoint John Venter to the RDC Board. D. Hawkins seconded the motion. Passed 4-0-1 with J. Sayler abstains.
- Follow-up Discussion on New Law Concerning Electronic Participation in Council Meetings.
  - o K. McGinnis received an estimate from TXC Solutions.
  - R. Hill would like to see a sampling of one they installed somewhere else. Other Council members would like to see it also.
- ARPA Funds
  - D. Hendrickson stated a meeting occurred with Baker Tilly. The requests will be brought to the next Council meeting.

- Opioid Settlement Summary and Guidance
  - The Town had previously opted in to participate in the settlement with the Attorney Generals
    office. S. Watson recommended a motion to opt in. L. Fleury made a motion to opt in to the
    States Opioid settlement. R. Hill seconded the motion.

## **New Business**

- Resolution 2021-20, Declaratory Resolution for Abatement for Hines 2
  - Will Renner, representative for Hines showed power point of the development in Phase II.
     Project will close by the end of the year and break ground by April of 2022.
  - o 60 acres for a total of two buildings
  - o Capital expenditure will be \$36,000,000 to \$48,000,000.
  - o Phase I timeline is on schedule.
  - S. Watson doesn't see anything out of the ordinary.

- Briar Creek Section 1 & 2 Dedication and Acceptance of common Area Sidewalks, Road Surface and associated Maintenance Bonds.

- Ordinance 2021-15, Amending Maintenance Bond Requirements of Subdivision Control Ordinance.
  - J. Boshell has proposed the language providing more protection for the Town. Increase the amount to be equal to 25 % of the cost of the Public Improvements and a period of 5 years.
     Recommends approval for more protection for the Town.
  - B. Goedeker made a motion to approve ORD 2021-15 amending requirements. L. Fleury seconded the motion. Passed 5-0. B. Goedeker made a motion to suspend the rules. L. Fleury seconded the motion. Passed 5-0. B. Goedeker made a motion to approve ORD 2021-15 for final reading.

- Resolution 2021-21, Sale of an old Ambulance to the Town of Bargersville
  - o Chief Eric Funkhouser stated he was approached to purchase an old ambulance (as is) that is currently not in use, to the Town of Bargersville for \$7,500. All items inside will be removed.
  - D. Hawkins made a motion to approve the sale of the ambulance for \$7,500 to the Town of Bargersville. B. Goedeker seconded the motion.
