- Ordinance 2021-09 Approving Modification of Zoning Commitment for W95RE.
 - Eric Prime, VanValer Law Firm, summarized previously there was more commercial and less industrial. Due to economy and Covid situations, desire for office space has nearly gone away so condensing the commercial to make room for a larger light industrial space by moving the line. 16 ½ acres for retail, hotels and restaurants. Commitments and Annexation has not changed, just moving the existing line dividing the two. D. Hawkins made a motion to approve Ord. 2021-09 first reading. B. Goedeker seconded the motion.

New Business

- Millstone Section 3 Dedication and Acceptance of Asphalt Surface, Erosion Control, and Curbs and association Maintenance Bonds.
 - o J. Boshell, Senior Planner asked the Town for acceptance.
 - o Three-year Bond means anything that needs repairs will have to be fixed.
 - D. Hawkins inquired how long can they take to do the repairs. J. Boshell stated probably 30 days. R. Hill agrees no long than 10 days. D. Hawkins would like for it to be written in their bond to be completed in 30 days.
 - o R. Hill would like for it to be as soon as possible and not to exceed past 30 days.
 - o S. Watson states we have to give the developer 15 days before we proceed to process the bond.
 - K. McGinnis stated he would like to change the ordinance, along with J. Boshell, from 10% to 25% and update the design standards.
 - o D. Hawkins made a motion to table this until next month. R. Hill seconded the motion.

- Resolution 2021-18 Tax Abatement Building 5 Expansion
 - To amend the existing tax abatement to allow the building to expand further. 767,000 sq. ft to 980,00 sq. ft. which will be more of an investment with the same terms accepted for the smaller building. The only thing changing is the size of the building. B. Goedeker seconded the motion.

Town Manager Report

- Springhill Subdivision will begin in mid-August for new paving, curbs and sidewalks through Community Crossings Grant.
- New Town Webpage soon to be completed.
- Community Day will be on September 18, 2021 from 12-4. Mike Wood of Baily & Wood Mortgages will be donating the Fireworks later that night.
- Meeting with Republic Trash Removal on August 18. S. Watson is looking at the current contract.
- County TIF still in discussion is still ongoing. They have no infrastructure east of l65 so they would need our utilities. Another meeting on August 30.
- Kingsbridge subdivision in Franklin, has been approved with a cul-de-sac next to Park Forest. The road is approximately 10 feet away from the connection point to Park Forest.
- Aspire Group stated there is someone looking for a place to open up a new manufacturing to be
 deployed in 2 phases and want to know by 8/12/21 if it would be a consideration by the Town Council
 for a personal property tax abatement for five years.
 - o The Town has only given personal property abatement one other time.
 - J. Sayler stated he wouldn't be against considering. B. Goedeker made a motion of intent to consider. L. Fleury seconded the motion.
