- Clerk Treasurer reported balances on all operating funds. K. McGinnis passed handouts.

 - o R. Hill inquired about the \$600,000 distribution. D. Hendrickson stated it shows under the Local Road and Bridge Fund 258
 - J. Sayler inquired why the differences from May balances to June on Sewer Operating Fund. D.
 Hendrickson explained the spreadsheet numbers were not done by her and K. McGinnis stated he get them an answer later.

Old Business

- Ordinance 2021-16, PUD Rezoning for Grayhawk Village
 - J. Boshell stated it is continued to the next meeting.
- Discussion of Development ARPA Plan
 - O D. Hendrickson stated the proposals for expenditure was given last month from the Police and Fire and the Town. S. Watson stated the Plan has to be completed before any funds can be use.

- O. Hendrickson stated as in last months' meeting the Town could use the Loss of Revenue for putting the money into the General Fund.
- J. Sayler would like to see an immediate use proposal sent to Council emails.
- A comment was made the Police and Fire made their numbers submitted pending the Town's needs were bonding for the Sewer Plant
- O. D. Hawkins stated he would like to see the Sewer use the new bond for all Sewer Plant needs.
- J. Sayler would like to see rank of needs.
- Follow-up Discussion on New Law Concerning Electronic Participation in Council Meetings.

 - o Uptown Commercial Partners requesting 40 acres across from Cooper Tire to be rezoned.
 - The last piece on the southside of Whiteland Rd.
 - o 400,000 sq. ft. speculative warehouse
 - J. Sayler inquired from Eric Prime, representative of Uptown Commercial Partner, if his client
 would be interested in doing a private partnership to help upgrade the lift station in the area
 since it is at maximum limit? He does not know as of right now since they are only in the rezone
 portion. J. Boshell stated it was mentioned to the petitioner about the lift station situation.

- o BZA appointment Executive Approval for 2022: Leslie Beeson
 - J. Sayler nominated Leslie Beeson for until the reorganization of the Town Council in January 2022.

Town Manager Report

- o Amanda Rubadue Aspire Johnson County
 - VP of the Economic Development Organization which is the result of a merger with Johnson County Development Corporation and the Greater Greenwood Chamber.
 - There are several volunteer teams working for economic development.
 - 40 different action steps to help in Johnson County.
 - Expand opportunities for companies already here in Johnson County especially with employment of the future.
- o Shelby Howard DE annexation
 - Contacted by City of Greenwood Sewer Superintendent about entering into an inner-local agreement for the property involved. K. McGinnis stated the Town would need to see the agreement first.
 - J. Sayler states the agreement seems to be the easiest way to handle the situation.
 - S. Watson stated he would probably not be involved due to the fact his firm also works for the City of Greenwood.
- Design Standards Update
 - Going through final approval. 13-page document to a 300-page document so the Town will be better protected.
- TIF District, Johnson County
 - The Town of Whiteland did not demand as much as Franklin or Greenwood.
 - K. McGinnis was working with the County in negotiation, had a philosophy of matching the comprehensive plan and stay inside a certain area east of I65 and what made sense.

- Plans to attend the next Johnson County RDC meeting.
- J. Sayler stated he was frustrated about the erroneous information in the Daily Journal publication about the TIF area. Johnson County cannot be controlled.
- Commissioner Baird stated if the County doesn't bond then he would be willing to work with the Town in the future.
- o Department Head Updates
 - J. Boshell, Senior Planner, in early 2022 we will have the design standards updated.
- o Springhill Subdivision
 - Sidewalks are getting started.
 - Per the agreement, Wallace had a one-year maintenance bond. Due to the road situations, we reached out to Wallace to change it to a three-year maintenance bond with a small cost. If there was a defect that happened within the three years, we can pull the bond. It would come at the cost of the Town since the first year was the only one in the contract. J. Sayler and B. Goedeker agrees the bond is necessary. R. Hill inquired if that would be in writing. K. McGinnis stated yes. S. Watson recommended at the January meeting to have change order #4 to reflect.
