ADDITIONAL APPROPRIATION AND TRANSFER RESOLUTION FOR BUDGET YEAR 2021

(Community Crossing Matching Grant Fund)

WHEREAS, the Town of Whiteland ("Town") Town Council has received \$378,267.75 Community Crossing Matching Grant from the Indiana Department of Transportation ("INDOT") for certain infrastructure improvement projects;

WHEREAS, the Town's matching funds requirement for such grant is in the amount of \$126,089.25;

WHEREAS, it has been determined that it is now necessary to appropriate additional matching funds from the Whiteland Local Road and Street Fund ("LRS Fund") in the amount of \$130,000;

WHEREAS, I.C. 8-23-30 authorizes matching grants to local units to be used for eligible projects undertaken by a local unit that repair or increase the capacity of local roads and bridges and that are part of the local unit's transportation asset management plan (the "Restricted Infrastructure Uses");

WHEREAS, the Town's matching funds need to be transferred to the Town's LOCAL ROAD AND BRIDGE MATCHING GRANT FUND; and

WHEREAS, the Town Council has published notice in accordance with Ind. Code §§ 5-3-1 and 6-1.1-18-5, and held a public hearing regarding the appropriations within this Resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE WHITELAND TOWN COUNCIL AS FOLLOWS:

- 1. The \$378,267.75 in Community Crossing Matching Grant funds from INDOT are hereby authorized to be deposited into the Local Road and Bridge Matching Grant Fund and such funds are APPROPRIATED to be used for the construction/reconstruction of roads and streets of the Town of Whiteland consistent with the permitted Restricted Infrastructure Uses.
- 2. The amount of \$130,000 in the LRS Fund is hereby appropriated to be used for the construction/reconstruction of roads and streets of the Town of Whiteland consistent with the permitted Restricted Infrastructure Uses.
- 3. The appropriations in this Resolution are in addition to all other appropriations of the Council and the Town for 2021.
- 4. The Clerk-Treasurer is hereby authorized and directed to provide information and a copy of this appropriation Resolution to the State Department of Local Government Finance.
