**RESOLUTION NO. 2021-21**

**A RESOLUTION APPROVING THE SALE OF AMBULANCE TO THE TOWN OF**  
**BARGERSVILLE**

WHEREAS, Ind. Code § 36-1-11-8 provides that a “transfer or exchange of property may be made with a governmental entity upon terms and conditions agreed upon by the entities as evidenced by adoption of a substantially identical resolution by each entity;”

WHEREAS, Ind. Code § 36-1-11-8 provides that “[s]uch a transfer may be made for any amount of real property, cash, or other personal property, as agreed upon by the entities;”

WHEREAS, the Town of Whiteland (the “Town”) is in possession of a 2003 Ford Ambulance E-450 7.3 liter diesel AEV Trauma Hawk with VIN 1FDXE45FX3HA93809 (hereafter “Ambulance”), the Town Council has determined that the Ambulance is no longer needed by the Town, the Town has determined that \$7,500 is a fair and reasonable valuation of the Ambulance, and the Town Council desires to sell the Ambulance to the Town of Bargersville for a sum of \$7,500;

WHEREAS, the Town of Bargersville desires to purchase the Ambulance from the Town of Whiteland for a sum of \$7,500, pending adoption of a substantially identical resolution by the Town of Bargersville; and

WHEREAS, the Town Council has determined that it would be in the best interest of the Town to sell the Ambulance to the Town of Bargersville pursuant to Ind. Code § 36-1-11-8.

NOW, THEREFORE, BE IT RESOLVED BY THE WHITELAND TOWN COUNCIL AS FOLLOWS:


Section 1. An exchange of property with the Town of Bargersville is hereby approved whereby the Town of Bargersville will exchange \$7,500 to be paid to the Town of Whiteland, for the 2003 Ford Ambulance E-450 7.3 liter diesel AEV Trauma Hawk with VIN 1FDXE45FX3HA93809 to be conveyed by the Town of Whiteland to the Town of Bargersville.

Section 2. The Whiteland Town Manager and the Whiteland Fire Department, through its Chief, Eric Funkhouser, are hereby authorized to execute all documents necessary or desirable to facilitate the sale and exchange of the Ambulance as contemplated by this Resolution.
