 - o In 2019 the RDC help funded the Round a bout on Whiteland Rd.
 - When the TIF district expires then the other entities will receive the funds.
 - o Yearly there will be a determination to capture of excess value.
 - B. Zike stated Norm Gabehart was responsible for the building out by the Interstate before his retirement. Inquired if the new Town Manager would be expected to do the same? D. Hawkins replied he hoped so.
 - In 2017 the Redevelop Commission discussed possibly giving the school district a 10% of TIF Funds. The process has not been put into action yet because there have not been enough funds collected yet. It will require a contract of sort.
 - The Redevelop Commission stated they would not capture funds off of an apartment project.
