RESOLUTION NO. 2022-07**

**ADDITIONAL APPROPRIATION RESOLUTION FOR BUDGET YEAR 2022  
APPROPRIATING ADDITIONAL FUNDS RECEIVED FROM THE AMERICAN  
RESCUE PLAN ACT OF 2021**

WHEREAS, the Town of Whiteland (the “Town”) originally projected to receive approximately \$1,023,000 under the American Rescue Plan Act of 2021 (“ARP”), in two installments, with fifty (50%) of the funds having already been received by the Town in 2021, and fifty (50%) of the funds to be received in 2022, which funds have earned interest and will continue to earn interest until expended (collectively, the “ARP Funds”);

WHEREAS, the Town has received an additional supplemental distribution of ARP Funds in the amount of \$1,936.49;

WHEREAS, the Town Council plans to use the additional ARP Funds for technology purchases for the Whiteland Clerk-Treasurer’s Office;

WHEREAS, the Town has published notice in accordance with Ind. Code §§ 5-3-1 and 6-1.1-18-5, and held a public hearing regarding the appropriation within this Resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE WHITELAND TOWN COUNCIL AS FOLLOWS:

1. An appropriation of \$1,936.49 from the ARP Coronavirus Local Fiscal Recovery Grant Fund 176 (the ARP Funds) is hereby made as follows:

Clerk-Treasurer, \$1,936.49 of the ARP Funds is allocated for use by the Whitland Clerk-Treasurer’s Office for the purchase of new technology, including but not limited to, a laptop computer and typewriter.

2. The appropriations in this Resolution are in addition to all other appropriations of the Town Council and the Town for 2022.


3. The Clerk-Treasurer is hereby authorized and directed to provide information and a copy of this appropriation Resolution to the State Department of Local Government Finance.
