

**NOTICE OF A HEARING ON  
PROPOSED REDUCTION OF WHITELAND WATER UTILITY RATES AND  
CHARGES**

Users of and owners of property served or to be served by the **Town of Whiteland Water Utility**, and other interested persons, are hereby notified that **Whiteland Town Council Ordinance No. 2022-06, AN ORDINANCE AMENDING THE RATES AND CHARGES FOR THE TOWN OF WHITELAND'S WATERWORKS TO REFLECT THE ELIMINATION OF THE UTILITY RECEIPTS TAX**, will be introduced at the meeting of the Whiteland Town Council to be held at 7:00 p.m. on June 14, 2022, at the Whiteland Town Hall, 549 Main St., Whiteland, IN 46184, and immediately following its introduction at such meeting, will be the subject of a public hearing. In summary, the amended water rates and charges decrease the monthly rates and charges in accordance HEA 1002, which repealed the Utility Receipts Tax, decreasing the rates and charges approximately 1.3985%. The proposed amended schedule of water rates and charges is as follows:
