SECTION 1: Economic Development Commission (3members), Redevelopment Commission (5 members), Plan Commission (7 members), Board of Zoning Appeals (5 members), Park Board (4 members), and Board of Storm Water Mgmt (3 members) at \$75 a month per meeting per month maximun, paid only if in attendance at the regularly scheduled meetir

SECTION 2: The Economic Development commission, Redevelopment Commission, Plan Commission, Board of Zoning Appeals, Park Board, andBoard of Storm Water Mgmt. to be paid on the regularly schedule pay date quarterly. Meeting attendance to be kept by the Clerk-Treasurer.

SECTION 3: Salary of all full-time employees shall include holiday pay and other benefits provided under the **Employee Handbook**, adopted by the Town Council on December 8, 2020

SECTION 4: Annual Salaries for Deputy Marshals are based on a 28 day work period of 171 hours. Hours worked in excess of 171 per 28 day work period shall be compensated at one and one-half times the regular hourly rate, in excess of 171, by the hourly rate, as defined under the Fair Labor Standards Act (FLSA).

SECTION 5: The Whiteland Fire Department has adopted a 28-day work period. Salaries and wages are based on a 28-day work period consisting of 212 hours. Hours worked in excess of 212 per 28-day work period shall be compensated at one and one-half times the regular hourly rate, as defined under the Fair Labor Standards Act (FSLA), in accordance with §207(k) of the FLSA

SECTION 6: The Town of Whiteland Clerk-Treasuer is a full-time elected official receiving benefits in addition to the annual salary. These benefits include the following: Health, Life, Dental & Vision - \$17,788.80, Health Reimbursement Arrangement (HRA) - \$1,250, and Longevity - \$800. The total benefits received equals - \$19,838.80. (IC 36-5-3-6)

SECTION 7: The Clerk-Treasurer shall process all payroll bi-weekly without Town Council approval.

SECTION 8: All appointed full-time employees and all other full-time employees shall be required to work 40 hours per week. Salaries and wages are based on 2080 hours in the year 2023, except for Deputy Marshals, Fire Chief, Deputy Fire Chief, Fire Marshall and Firefighters, where Section 4 or Section 5, as the case may be, shall prevail. All employees non-exempt under the FLSA are denoted with an asterisk (*) by the position title.
