RESOLUTION NO. 2022-19

A RESOLUTION APPROVING THE PURCHASE OF A FIRE LADDER TRUCK FROM
THE CITY OF GREENFIELD

WHEREAS, Ind. Code § 36-1-11-8 provides that a “transfer or exchange of property may be made with a governmental entity upon terms and conditions agreed upon by the entities as evidenced by adoption of a substantially identical resolution by each entity;”

WHEREAS, Ind. Code § 36-1-11-8 provides that “[s]uch a transfer may be made for any amount of real property, cash, or other personal property, as agreed upon by the entities;”

WHEREAS, the City of Greenfield, Indiana possesses title to and ownership of a 2000 KME 102-foot Rear Mount Ladder Truck, VIN IK9AF6486IN058275 (“Ladder Truck”) having used this unit for various firefighting purposes but it is no longer needed by the City of Greenfield, Indiana as it has been replaced by a newly purchased ladder truck unit;

WHEREAS, the Town of Whiteland (“Town”) Town Council has determined that it would be in the best interest of the Town to purchase the Ladder Truck from the City of Greenfield, Indiana, in exchange for the sum of \$75,000.00, pursuant to Ind. Code § 36-1-11-8; and

WHEREAS, the City of Greenfield, by and through its Board of Public Works and Safety, has adopted a substantially similar resolution approving the sale of the Ladder Truck to the Town.

NOW, THEREFORE, BE IT RESOLVED BY THE WHITELAND TOWN COUNCIL AS FOLLOWS:

Section 1. An exchange of property with the City of Greenfield is hereby approved whereby the Town of Whiteland shall pay \$75,000 to the City of Greenfield, in exchange for possession of and all right and title to the 2000 KME 102-foot Rear Mount Ladder Truck, VIN IK9AF6486IN058275, to be conveyed by the City of Greenfield to the Town of Whiteland within 30 days after the adoption of this Resolution.

Section 2. The Whiteland Town Manager and the Whiteland Fire Department, through its Chief, Eric Funkhouser, are hereby authorized to execute all documents necessary or desirable to facilitate the purchase of the Ladder Truck as contemplated by this Resolution.


