## **RESOLUTION NO. 2023-11**

## A RESOLUTION AUTHORIZING AN INTERLOCAL AGREEMENT BETWEEN THE CITY OF FRANKLIN AND THE WHITELAND REDEVELOPMENT COMMISSION REGARDING CERTAIN ROAD IMPROVEMENTS AT THE INTERSECTION OF GRAHAM ROAD AND PAUL HAND BOULEVARD

WHEREAS, Ind. Code § 36-1-7 et. seq. (the "Act") permits a political subdivision to exercise jointly with any other political subdivision any power, privilege, or authority which such political subdivisions share in common and which each might exercise separately by and through interlocal agreements;

WHEREAS, the City of Franklin ("City") desires to design and construct certain road improvements located at the intersection of Graham Road and Paul Hand Boulevard in Franklin, Indiana (the "Graham/Paul Hand Roundabout") and has requested the financial assistance of the Town of Whiteland ("Town") to complete the Graham/Paul Hand Roundabout;

WHEREAS, at its meeting on August 10, 2023, the Town of Whiteland Redevelopment Commission (the "Commission") approved, pending legal review, the Commission entering into an interlocal agreement with the City to contribute \$750,000 for the design and construction of the Graham/Paul Hand Roundabout (the "Interlocal Agreement"); and

WHEREAS, the Act requires that interlocal agreements be entered into pursuant to an ordinance or resolution of each of the parties to the interlocal agreement.

NOW, THEREFORE, BE IT RESOLVED by the Town of Whiteland Redevelopment Commission, as follows:

- 1. The President and Secretary of the Commission are hereby authorized and directed to enter into an Interlocal Agreement between the Commission and the City of Franklin by which the Commission will contribute \$750,000 for the design and construction of the Graham/Paul Hand Roundabout, subject to the approval of the form of the Interlocal Agreement by the Town Director of Administration and the Town Attorney.
- 2. A fully executed Interlocal Agreement shall be recorded in the Office of the Recorder of Johnson County and filed with the State Board of Accounts, and two (2) copies of the Interlocal Agreement shall be filed in the office of the Clerk-Treasurer, and the Commission directs the Clerk-Treasurer to maintain for public inspection two (2) copies of said Interlocal Agreement in the files of the Clerk-Treasurer.
- 3. The sections, paragraphs, sentences, clauses, phrases, and words of this Resolution are separable, and if any word, phrase, clause, sentence, paragraph, or section of this Resolution shall be declared unconstitutional, invalid, or unenforceable by the valid judgment or decree of a court of competent jurisdiction, such unconstitutionality, invalidity, or

unenforceability shall not affect any of the remaining words, phrases, clauses, sentences, paragraphs, and sections of this Resolution.

4. This Resolution shall be effective as of its date of adoption.
