

**WHITELAND TOWN COUNCIL
RESOLUTION NO. 2023-16**

**ADDITIONAL APPROPRIATION AND TRANSFER RESOLUTION FOR BUDGET
YEAR 2023**

(Community Crossing Matching Grant Fund)

WHEREAS, the Town of Whiteland (“Town”) Town Council has received a \$565,049.62 Community Crossing Matching Grant (the “CCMG Grant Funds”) from the Indiana Department of Transportation (“INDOT”) for certain infrastructure improvement projects;

WHEREAS, the Town’s matching funds requirement for such grant is in the amount of \$188,349.88 (\$47,000.00 from the Storm Water Utility, which does not have to be appropriated, and \$141,349.88 from the Motor Vehicle Highway (MVH) Restricted Fund);

WHEREAS, I.C. 8-23-30 authorizes matching grants to local units to be used for eligible projects undertaken by a local unit that repair or increase the capacity of local roads and bridges and that are part of the local unit’s transportation asset management plan (the “Restricted Infrastructure Uses”);

WHEREAS, the Town’s matching funds need to be transferred to the Town’s LOCAL ROAD AND BRIDGE MATCHING GRANT FUND;

WHEREAS, due to a change order on the street paving project for which the CCMG Grant Funds are being used, the Town also need to make an additional appropriation in the amount of \$5,872.94 from the Motor Vehicle Highway (MVH) Restricted Fund; and

WHEREAS, the Town Council has published notice in accordance with Ind. Code §§ 5-3-1 and 6-1.1-18-5, and held a public hearing regarding the appropriations within this Resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE WHITELAND TOWN COUNCIL AS FOLLOWS:

1. The \$565,049.62 in Community Crossing Matching Grant funds from INDOT are hereby authorized to be deposited/transferred into the Local Road and Bridge Matching Grant Fund and such funds are APPROPRIATED to be used for the construction/reconstruction of roads and streets of the Town of Whiteland consistent with the permitted Restricted Infrastructure Uses.
2. The amount of \$147,222.82 in the Motor Vehicle Highway (MVH) Restricted Fund appropriation number 2203001363.000 is hereby authorized to be deposited/transferred into the Local Road and Bridge Matching Grant Fund and such funds are hereby APPROPRIATED to be used for the construction/reconstruction of roads and streets of the Town of Whiteland consistent with the permitted Restricted Infrastructure Uses.
3. The amount of \$47,000.00 in the Stormwater Utility Fund is hereby authorized to be deposited/transferred into the Local Road and Bridge Matching Grant Fund for the

construction/reconstruction of stormwater improvements that are part of the construction/reconstruction of the roads and streets of the Town of Whiteland consistent with the permitted Restricted Infrastructure Uses.

4. The appropriations in this Resolution are in addition to all other appropriations of the Council and the Town for Budget year 2023.
5. The Clerk-Treasurer is hereby authorized and directed to provide information and a copy of this appropriation Resolution to the State Department of Local Government Finance.
6. This Resolution shall be in full force and effect retroactive to November 8, 2022, and all expenditures of the above referenced funds made toward the costs of construction/reconstruction of roads and streets of the Town of Whiteland consistent with the permitted Restricted Infrastructure Uses prior to the date of adoption are hereby ratified.




